By - Laws Of The Association

1. Ram Registrations

All Dorper and White Dorper rams used in a member's flock shall be registered with the Australian Dorper and White Dorper Association Inc.

2. Ram Registrations and Transfers

All Dorper and White Dorper rams sold for stud purposes must be registered and transferred within 30 days of sale. Registration / transfer forms must be forwarded to the Australian Dorper and White Dorper Association Inc. with all relevant fees. A copy of the paperwork should be forwarded to the purchaser at the same time.

3. Ewe Transfers

All Dorper and White Dorper ewes sold for stud purposes are to be transferred to the purchaser. Copies of the transfer together with the relevant fees are to be forwarded to the Australian Dorper and White Dorper Association Inc. within 30 days of the sale.

4. Flock Book - Appendix System

Only Fullblood and Purebred rams can be used to Appendix sheep

- a) F 1 Appendix ($\frac{1}{2}$ bred) is a cross between a Dorper or White Dorper with any breed ewe
- b) F2 Appendix (3/4 bred) is a cross between a Dorper or White Dorper with a F1 ewe.
- c) F3 Appendix (7/8 bred) is a cross between a Dorper or White Dorper with a F2 ewe
- d) F4 sheep 15/16th is classed a Domestic Purebred , both Rams and Ewes can be registered in the ADWDA stud book.

5. Eligibility for Shows / Exhibitions

For Dorper and White Dorper sheep to be eligible for entry into shows / exhibitions they must be eligible for registration as a Dorper or White Dorper sheep.

6. Stud reactivation

Dorper and White Dorper Studs seeking to reactivate and whose active membership has lapsed for a period greater than twelve (12) months, will be charged a lapsed membership fee for elapsed year eqivalent to the membership fee. In addition all stud sires used during the lapsed period must be registered with the ADWDA.

7. Transfer of prefix and flock number.

For a transfer of ownership of a prefix and flock number the member must sell a minimum of 75% of the stud to another member or sheep breeder. The transfer must link the prefix and flock number together.

8. Export Protocols

The Australian Dorper and White Dorper Association Inc. will sign off on any export request acknowledging that the individual concerned is a member of the Australian Dorper and White Dorper Association Inc. At the same the ADWDA will advise that it will not provide any further declarations.

9. Import Protocols

Any member importing Dorper or White Dorper genetics must forward to the secretary of the ADWDA a copy of Registion, Transfer and Pedigree of the genetics imported.
